The undersigned Amway Business Owner (ABO) is applying to enroll in the XS HUB Premises Selling Program (the "Program"). Enrollment in the Program is subject to approval by Amway Philippines (Amway) and is open to ABOs who are authorized by Amway to sell and display Amway Products at Limited Retail Service Establishments pursuant to Rule 4.3.1 of the Rules of Conduct and the Amway XS Products Policy. ABOs can apply for authorization by filling out and submitting a Request for Authorization to Sell and Display Amway Products at Limited Retail Service Establishments which can be found at: _____

To participate in the Program, ABOs must continue to comply with the Amway Rules of Conduct, the Amway XS Products Policy, and the terms and conditions of the Program which may be changed from time to time.

The Program operates as follows:

- The enrolling ABO must purchase sixteen thousand two hundred pesos (PHP 16,200, equivalent of 216 cans or 9 cases) of XS Energy Drink products per month for the six (6) consecutive months after enrollment.
- Within the first month after enrollment, Amway will provide the ABO (subject to availability) an XS Energy Drink branded refrigerator to store and display XS Energy Drinks in the Limited Retail Service Establishment. Please note there is a limit of one refrigerator per Limited Retail Service Establishment.
- Upon completion of the purchase requirement, the ABO will keep the refrigerator at no additional cost to the ABO.
- If the ABO fails to timely complete the purchase requirement, returns any of the products purchased as part of the purchase requirement, withdraws from the Program, or fails to meet any of the Program terms and conditions, the ABO agrees to pay Amway for the XS Energy Drink branded refrigerator in the amount of: _____ PHP. Payment will be due immediately upon request by Amway. Amway reserves the right to deduct the amount due from any bonuses or other amounts due to the ABO from Amway. Amway will accept return of the refrigerator in lieu of payment if the refrigerator is in good, working condition, and is returned within 30 days from the date of delivery.

Please note that the Amway XS Energy Drink branded refrigerator is supplied by a third party and comes with a manufacturer's warranty. Amway is not responsible for repairs, maintenance or replacement of the refrigerator. ABO releases, and will hold harmless and indemnify Amway, its related entities, directors, officers, employees and agents, from and against any losses, damages, liabilities, claims, demands, causes of action and expenses arising out of, or in connection with the use of the Amway XS Energy Drink branded refrigerator.

In order to administer this Program, Amway may disseminate all or part of the information contained in this form, or subsequently generated by your activities pursuant hereto, to parties with whom Amway works to process such data, including ABOs in your upline or downline organization, both within and outside the Philippines.
